Residents Survey Results Video

Kevin reported that over 120 people viewed the video about the survey results but noted that only 5 completed the following survey regarding the provision of further information. It is possible that the flyer detailing the results and the video provided sufficient information.

Government Consultation on the White Paper on Planning

A discussion took place about our response and also the response of the Parish Council. There was agreement in all areas but the Parish Council also noted that the move to greater use of "digital technology" would prevent many members of our community from being able to take part in Planning matters.

Kevin and Clive, together with other Parish Council participants, have also attended a West Berkshire Council Parish Conference and were able to see a presentation on this subject. Generally, there was concern about the contents of the White Paper and the possible impact on Neighbourhood Plans.

Bryan Lyttle, Planning Officer, West Berkshire Council, advised those Parish Councils who had Neighbourhood Plans underway to continue and suggested focussing on "building codes".

Interestingly, no recommendation was offered to those Neighbourhood Plans that have not started yet.

West Berks Housing Strategy Consultation

Tilehurst Parish Council need to respond to this consultation by November 10th and Kevin asked for any feedback on the document. Unfortunately none was forthcoming as no one had seen the document except himself and Clive, who noted that it's main focus was on issues homelessness.

<u>Planning Policy Email sent by West Berkshire Council to Steering Group, Tilehurst Neighbourhood Plan.</u>

A confidential discussion took place about the contents of the email with regards to the numbers of new dwellings planned for Tilehurst Parish up until 2026 that will find their way into the Local Plan following the completion of the latest HEELA.

It was agreed that the results of this discussion will be fed into the draft document by Alan and Peter.
