Local Green Spaces

Peter has been working on a reworked "appendix" covering the allocation of Local Green Spaces and will make copies available, for review, in the coming days.

Discussion took place about those areas that have/have not been included together with the reasons for their inclusion/exclusion. It was agreed that most of the areas are deemed to be already adequately protected leaving only Pincents Hill to be considered. However, all the areas will be listed in the Neighbourhood Plan document detailing the reasons for their inclusion/exclusion.

Clive mentioned that an "evidence-gathering" day is being organised for the Pincents Hill area. Volunteers will be asked to observe how the area is currently being used. This is being organised by local volunteers, not the Tilehurst Neighbourhood Plan Steering Group. However, the information gathered will be reviewed by the Neighbourhood Plan team and added to the "evidence base".

Missing "Ecology Report" for Pincents Hill

It was raised in the last meeting, by members of the public, that the previously available "Ecology Report" is now no longer available to the public. Kevin has followed this up with several District Councillors who have confirmed that the document still exists but is not available on the West Berkshire Council website.

The reason given is that the report contains sensitive information such as the location of Badger Setts. When asked why a "redacted" version that excluded sensitive information could not be produced it was agreed by the District Councillors that they would pass the request back to West Berkshire Council.

<u>Draft Plan</u>

At the last Steering Group meeting it was noted that some significant changes may be required following feedback from West Berkshire Council. The council have indicated that many of the "policies" that are currently included in the Draft Plan should not be included as they are already covered in other documents (Local Plan etc.).

This effectively removes most of the areas where a Neighbourhood Plan can influence the future development of the parish.

It would appear that the only areas left are Local Green Spaces and Site Design Brief.

A lengthy discussion took place about the fact that other Neighbourhood Plans, including Stratfield Mortimer (West Berkshire) have had their plans approved whilst having policies included that are being suggested, by West Berkshire Council, should not be included in the Tilehurst Neighbourhood Plan.

Alan and Peter will spend the next few weeks putting together a revised, more comprehensive, Site Design Brief and update the Draft Plan to include the updated Local Green Spaces appendix and Site Design Brief.

The updated Draft Plan will then be made available for review before the next Steering Group meeting.

It was agreed that Liz Alexander, Bell Cornwell, should be invited to a meeting to discuss the revised Draft Plan document.

Footpath across Pincents Hill

A brief discussion took place about a recognised/not recognised footpath across Pincents Hill as it has been mentioned recently by members of the public. Clive to follow up and provide feedback.
